

**CITY OF WEST RICHLAND  
RESOLUTION NO. 36-22**

**A RESOLUTION OF THE CITY OF WEST RICHLAND, WASHINGTON, SETTING THE PUBLIC HEARING DATE TO CONSIDER AN ACCESS EASEMENT VACATION ON WILLAMETTE HEIGHTS SECTION 8, LOT 208, PARCEL NUMBER 1-0898-302-0208-000.**

**WHEREAS**, an application was submitted for an access easement vacation on Parcel Number 1-0898-302-0208-000, Willamette Heights Section 8, Lot 208 assigned File No. VACA-006-2022; and

**WHEREAS**, WRMC 12.40 establishes the method for vacating access easements, and WRMC 12.40.035 states that the legislative authority must take such action via ordinance following a public hearing; and

**WHEREAS**, the City Council shall adopt a resolution fixing the time when the easement application will be heard and determined in a public hearing, which time shall not be more than 60 days nor less than 20 days after the passage of the resolution per WRMC 12.60.020;

**NOW, THEREFORE, THE CITY COUNCIL FOR THE CITY OF WEST RICHLAND, WASHINGTON**, does hereby resolve as follows:

**Section 1.** There shall be a public hearing to consider the easement relinquishment application before the City Council of the City of West Richland, Washington, at its regularly scheduled meeting to be held on July 19, 2022 at 6:00pm.

**Section 2.** The easement sought to be vacated is affected portions of Lot 208 of Section 8 of the Willamette Heights Plat, Recorded in Volume 5 of Plats at Page 52, Records of Benton County, Washington, those portions being described as follows:


The east 33.00 feet of above said lot.

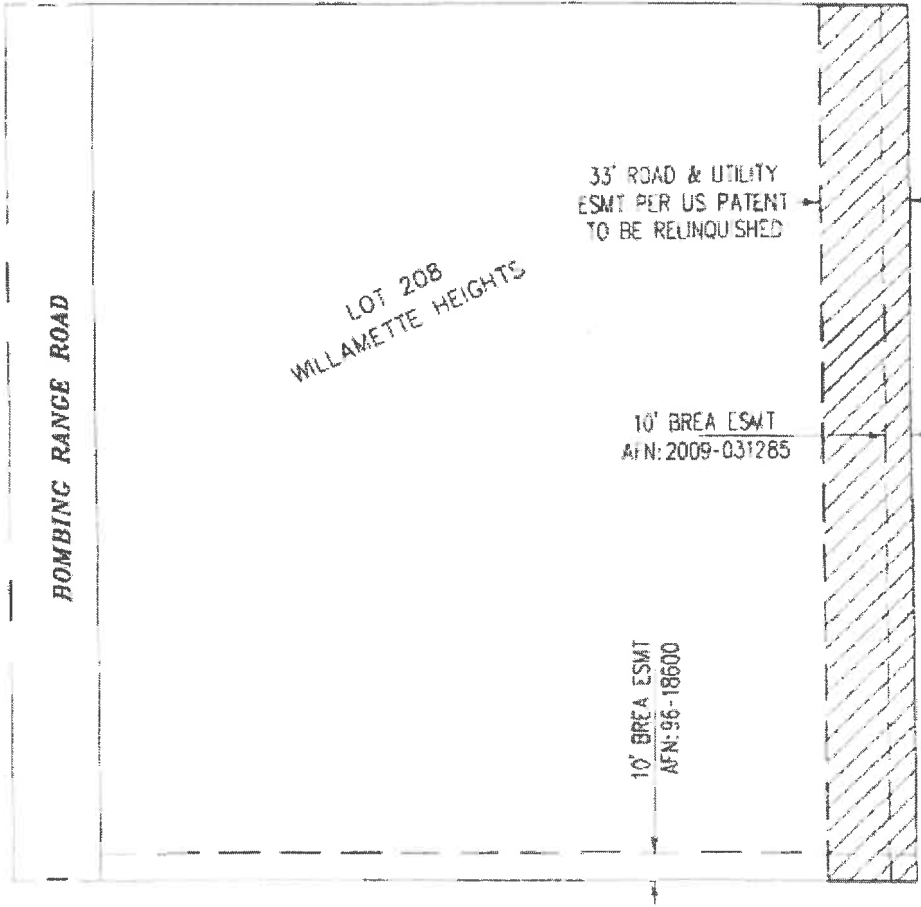
