**A RESOLUTION OF THE CITY OF WEST RICHLAND, WASHINGTON,  
AUTHORIZING THE MAYOR TO EXECUTE INTER-LOCAL AGREEMENT  
REGARDING THE 2022 WASHINGTON AUTO PREVENTION AUTHORITY  
(WATPA) PROGRAM AWARD.**

**WHEREAS**, the Kennewick Police Department and the West Richland Police Department, along with the Richland Police Department and the Benton County Sheriff's Department, collectively received one-time grant funding for the purchase of the Flock Safety System; and,

**WHEREAS**, this funding is allowing each agency to purchase automated license plate reader cameras and strategically deploy them across their jurisdictions; and

**WHEREAS**, the total grant award is \$132,789, which will be split between the collaborating entities, as they are certified as disparate, therefore requiring one application and award to be shared between the jurisdictions; and

**WHEREAS**, the initial grant funding for this project ends June 30, 2023; and

**WHEREAS**, this Agreement is made under the authority of RCW 39.34 and is intended to dictate the award amounts that will be provided to each party and to ensure how they are spent; and,

**WHEREAS**, each governing body, in performing governmental functions or in paying for the performance of governmental functions hereunder, shall make that performance or those payments from current revenues legally available to that party; and,



**NOW THEREFORE** the City Council of the City of West Richland, Washington, does hereby resolve as follows:



**Inter-local Agreement  
Between the City of Kennewick, WA and the City of West Richland, WA**

**2022 Washington Auto Theft Prevention Authority (WATPA) Program Award**

This agreement is made and entered into this 24<sup>th</sup> day of August 2022 between the City of Kennewick, WA and the City of West Richland, WA.

**Whereas**, the Kennewick Police Department and the West Richland Police Department, along with the Richland Police Department and the Benton County Sheriff's Department, collectively received one-time grant funding for the purchase of the Flock Safety System; and,

**Whereas**, this funding is allowing each agency to purchase automated license plate reader cameras and strategically deploy them across their jurisdictions; and

**Whereas**, the total grant award is \$132,789, which will be split between the collaborating entities, as they are certified as disparate, therefore requiring one application and award to be shared between the jurisdictions; and

**Now therefore, the City of Kennewick and the City of West Richland agree as follows:**

**Section 1**

The purpose of this Agreement is to dictate award amounts from the WATPA grant that will be reimbursed by the City of Kennewick to the City of West Richland for purchases approved under the terms of the grant.

**Section 2**

The City of Kennewick is the fiscal agent for this grant as the City of Kennewick submitted the grant on behalf of all participating agencies. The City of Kennewick agrees to reimburse the City of West Richland a total of \$32,024.00 of WATPA funds for the expenditures detailed in Sections 2 and 3.

### **Section 3**

The City of West Richland agrees to use \$30,980.00 to purchase Flock Falcon cameras \$1,044 to purchase Rat Trap tire deflation systems.

### **Section 4**

The City of West Richland will submit copies of paid invoices for their purchases to the City of Kennewick, attention Michele Hamada ([michele.hamada@ci.kennewick.wa.us](mailto:michele.hamada@ci.kennewick.wa.us)) with a reimbursement request for the funds spent. The City of West Richland will only be reimbursed up to the approved funding amount for each type of equipment.

### **Section 5**

The City of West Richland agrees to submit timely statistical reports to WATPA, which will be due by October 1, 2022, December 15, 2022, and June 15, 2023.

### **Section 6**

Nothing in the performance of this agreement imposes any liability for claims against the City of Kennewick.

### **Section 7**

Each party to this agreement shall be responsible for its own actions in providing services under this agreement and shall not be liable for any civil liability that may arise from the furnishing of services by the other party.

### **Section 8**

The parties to this agreement do not intend for any third party to obtain any right by virtue of this agreement.

### **Section 9**

By entering into this agreement, the parties do not intend to create any obligations express or implied other than those set out herein; further, this agreement shall not create any rights in any party not a signatory hereto.

### **Section 10**

The term of this agreement shall be through June 30, 2023. This Agreement shall be terminated at any time by the mutual consent of the PARTIES and formally expressed in writing and signed by the designated representative of each PARTY as outlined in Section 12.

### **Section 11**

By signing below, the signor certified that he or she has the authority to sign this agreement on behalf of the party, and the party agrees to the terms of this agreement.

### **Section 12**

Each party shall have a contract representative. Each party may change its representative upon providing written notice to the other party. The parties' representatives are as follows:

City of Kennewick: Chief Chris Guerrero

**Section 13**

The parties agree that this agreement is the complete expression of its terms and conditions. Any oral or written representations or understanding not incorporated in this agreement are specifically excluded.


