### **NOTICE OF PUBLIC HEARING**

In accordance with RCW 35.94.040 and West Richland Municipal Code Chapter 12.60, a public hearing to consider the proposed vacation of a public utility easement will be held before the West Richland City Council on **Tuesday, August 17, 2020 at 6:00 p.m.** The date and time of the public hearing was set by Council with the passage of Resolution #28-21 on July 20, 2021.

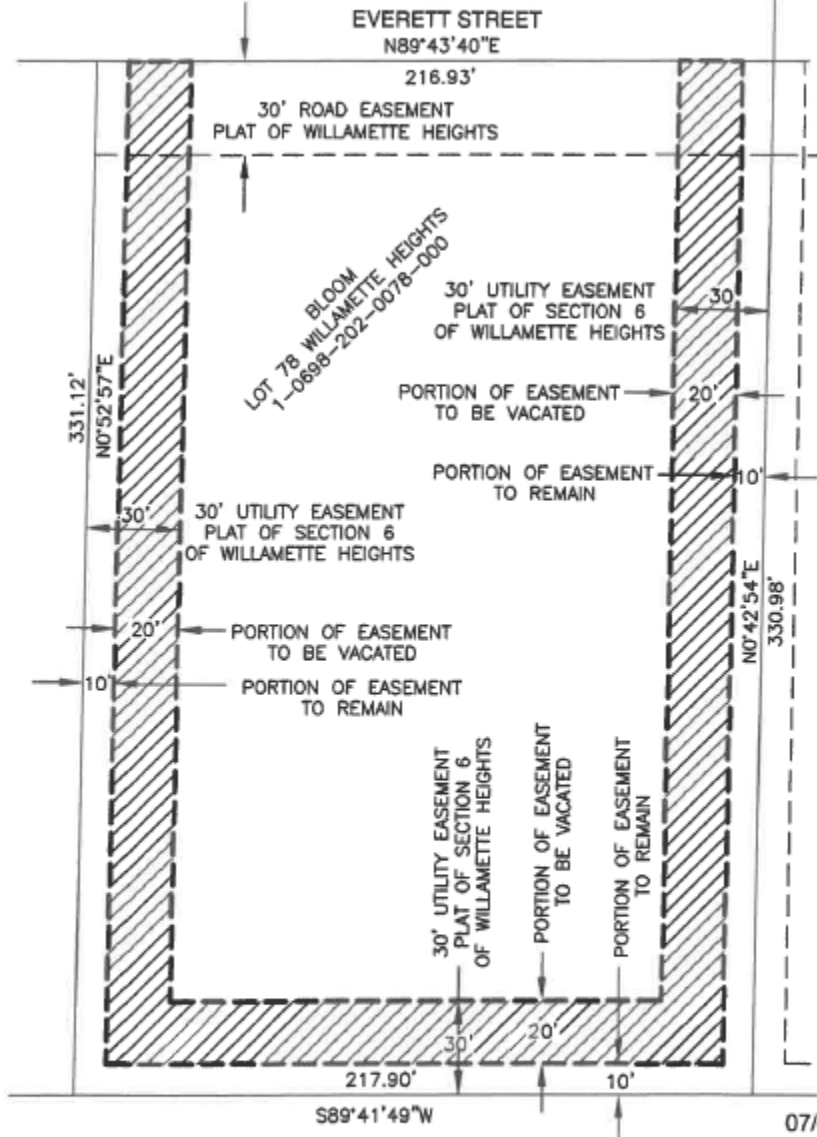
### **DESCRIPTION OF PROPOSAL**

The property owners, Richard and Ruth Bloom, submitted an application for a utility easement vacation, along with the applicable fee. The site is Willamette Heights Section 6, Lot 78, and is currently unaddressed (Parcel No: 106982020078000). The easement sought to be vacated is a portion of the 30' utility easement on the east, west, and south boundaries of the property.
