

**AMENDMENT #1  
INTERLOCAL AGREEMENT  
BETWEEN CITY OF WEST RICHLAND  
AND CITY OF BENTON CITY  
FOR STREET SWEEPING SERVICES**

THIS AMENDMENT IS ENTERED into by and between the CITY OF WEST RICHLAND, a municipal corporation of Benton County, Washington, hereinafter referred to as "West Richland" and CITY OF BENTON CITY, a municipal corporation of Benton County, Washington, hereinafter referred to as "BENTON CITY", for street sweeping services, and is effective January 1, 2013 upon execution by both parties.

WHEREAS, the City of West Richland and the City of Benton City on July 24, 2012 executed a Interlocal Agreement For Street Sweeping Services; and

WHEREAS, Section 4(C), General Terms, states Benton City recognizes that annual written amendments to the hourly street sweeping rate in Attachment B on January 1<sup>st</sup> shall be necessary to allow West Richland to be fairly compensated for labor and equipment associated with street sweeping services; and

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is acknowledged, City of West Richland and City of Benton City agree to the following amendment to Attachment B as follows:

## **Attachment B**

November 20, 2012

### Street Sweeping Services

2013 hourly rate, including labor, equipment, and administrative fee, shall be \$194.15/hr.  
(hourly rate to be charged from West Richland's shop to West Richland's shop)


Rate to be amended annually on January 1st






