- 1. Call to Order** – Chair Greg McDowell called the meeting to order at 5:55 p.m.
- 2. Roll Call** – Commissioners Mark Hanneman, Greg McDowell, Robert Perkes and Walter Tamosaitis were present. City Clerk Julie Richardson and City Attorney Bronson Brown were also present.
- 3. Approval of Agenda** – *Commissioner Perkes moved to approve the agenda as presented, seconded by Commissioner Hanneman. The motion carried unanimously.*
- 5. Approval of Minutes of Salary Commission Meeting of September 26, 2018.** *Commissioner McDowell moved to approve the minutes of September 26, 2018, seconded by Commissioner Hanneman. The motion carried unanimously.*
- 6. Discussion on Data Requested During 9-26-18 Meeting**

Commissioner McDowell commented on some of the accomplishments from the past two years, including the Comprehensive Plan update and near completion of the zoning code.

Commissioner Tamosaitis provided an overview of data he compiled with comparison data and percentage of increases in population, CPI, the city budget, employee salaries, and salaries of mayors in Mayor/Council cities with no city administrator.

Elected Official Salary Schedule

Mayor with City Administrator	\$2,000 monthly
City Council Member	\$550 monthly
